

## US LNG Weekly Recap - Week of 12/18/2025

**Things to Watch:** We are watching for Plaquemines feedgas demand to return above 4.0 Bcf/d as there is 0.3-0.4 Bcf/d of potential demand offline compared to the daily highs seen earlier in November. Feedgas has been below 4 Bcf/d since December 9th.

Weekly Highlights

**CP2:** Latest construction inspection report stated some pipe installation was occurring on CP Express and foundation work was ongoing at the LNG terminal site.

**Rio Grande LNG:** Construction continues on the LNG storage tanks 1 and 2, ongoing equipment installation for Trains 1 and 2, and commencing steel erection of Train 3 acid gas removal unit and Train 4 civil activities. They plan to commence Train 3 equipment installation this month.


**Golden Pass:** Received FERC approval for the Trident pipeline supply lateral interconnect, though there are a few recommendations that need to be addressed in the Environmental Assessment before they will receive a notice to proceed with activity.

**Louisiana LNG:** DOE approved request for an additional 44 months for the facility to reach first exports, extending the deadline to January 2030.

**Cedar LNG:** Pembina signs 12-year, 0.5 MTPA supply deal with Ovintiv completing the remarketing of Pembina's 1.5 MTPA of capacity.

**ST LNG:** The proposed 8.4 MTPA offshore deepwater terminal filed for DOE export permit approval with plans for first LNG in September 2029.

Daily L48 LNG Feedgas Total







## Change in Feedgas Deliveries by Facility









## Daily LNG Feedgas Deliveries by Facility - Prior 3 Months
